Throughout the day, attendees will be involved in modular work-based learning, during which an ongoing assessment will be undertaken. Following completion of the modules, all attendees will be fully accredited and have the necessary skills to make safe recruitment decisions.

- Setting of the budget between the Bursar and the Headteacher / Business Manager;
- The Budgetary control process throughout the year;
- Medium Term Financial Planning – this involves completing a forward plan in order to produce a forecast of the school's financial position for future years. This is particularly important given the current budget pressures that are being experienced.
