It will explain the questions you need to consider when commissioning Educational Psychology Services, be it private EPs or LA EPs. The session will give governors an awareness of how Stockton EPs approach casework. It may be helpful for governors to bring a 'problem' to allow the EPS to show you how they can use consultation (a model of EP work) to facilitate change. There will be opportunities for governors to raise questions about the work of EPs, perhaps based on what it is thought EPs do.
